Renton RFA/FD40 Finance Discussion

Commissioner Ryan and CAO Babich confirmed the initial proposition was brought to the board by Commissioner Schneider. The board decided to speak with Commissioner Schneider at the next regular meeting to identify the proposed need of contracting financial duties with Renton RFA.

NEW BUSINESS:

• 2024 Budget Timeline

Commissioner Ryan reviewed the 2024 budget timeline with the board. She informed the board King County has changed the format of the levy limit worksheet. To best accommodate the district's Resolution timeline, Commissioner Ryan proposed a Special

No discussion. Motion Approved (4-0). District Secretary Buckley will send a calendar invite to all commissioners.

Annual Open House Discussion

Commissioner Parsons presented the board with a review of the Open House plans. Renton RFA will provide co-branded items for giveaway to attendees. Commissioner Parsons is ordering additional items to align with the items provided by Renton RFA.

The Open House will be held at Station 17 on Saturday, October 28, 2023. Commissioners Pratt and Sartnurak will be attending the WFCA conference October 25-28, both will leave the conference early morning on the 28th to attend the Open House.

Board Attorney Quinn will be giving a presentation at the WFCA conference on "Speech in Social Media" and addressing the tribal obligation to pay for Fire and EMS services.

FINANCIAL REPORT:

Commissioner Ryan reviewed the District's 2nd quarter financial activity. 95% of the revenue received to date was obtained from the City of Renton paying off the full amount owed for Station 13.
