# Resolution No. 579: Property Tax Increase – 2024

Board Attorney Eric Quinn confirmed the resolution is required and submitted by the district annually to levy an increase in property taxes. The taxpayers will see an offset in their property taxes with a lessening of the assessed benefit charge.

It was Moved by Commissioner Parsons to adopt Resolution No. 579: Property Tax Increase – 2024 as written. Commissioner Sartnurak seconded. No discussion. Approved 4-0.

# Resolution No. 580: Property Tax Levy – 2024

Board Attorney Eric Quinn confirmed the resolution is required and submitted by the district to King County to levy taxes in calendar year 2024. The Resolution sets the District's 2024 property tax levy at \$1.00 per \$1,000.00 assessed value (\$4,680,000).

It was Moved by Commissioner Sartnurak to adopt Resolution No. 580: Property Tax Levy – 2024 as written. Commissioner Parsons seconded. No discussion. Approved 4-0.

# Resolution No. 581: Benefit Charge – 2024

Board Attorney Eric Quinn confirmed the resolution is required and submitted by the district to King County to establish the benefit charge amount assessed in calendar year 2024. The Resolution sets the 2024 benefit charge amount at \$1,900,000, which is over \$1 million less than in 2023.

It was Moved by Commissioner Ryan to adopt Resolution No. 581: Benefit Charge – 2024 as written. Commissioner Sartnurak seconded. No discussion. Approved 4-0.

## 2021 – 2022 Audit Update

The 2021 – 2022 accountability and financial audits audit are underway. Over the last 2-3 weeks Commissioners Ryan and Pratt and District Secretary Taylor have been gathering and submitting data requests. Commissioner Ryan informed the board an email was sent to all commissioners to join a virtual audit entrance conference on Monday, November 13<sup>th</sup> at 3:00 PM. By law, the auditor is required to invite the commissioners to an entrance conference, although commissioners are not required to attend. If three or more commissioners join the conference, it will create a quorum and a special meeting will need to be announced. Commissioners Sartnutak and Schneider expressed interest in attending the virtual conference, they will confirm their attendance through the email invitation, and there will be no quorum.

## **FINANCIAL REPORTS:**

Commissioner Ryan reviewed the district's Q3 2023 financial activity which was postponed from the October regular meeting due to 2024 budget planning. Funds were deposited into the GO Bond fund again, which King County has again assured has been resolved. The GO Bond fund was to be closed in 2022, and no additional funds were to be deposited into the account.

Jeff Wyborny, Citizen and KCFD40 Commissioner Position No. 1 Candidate, congratulated Commissioner Sartnurak on her electoral victory. He expressed his desire to explain his reasoning for running in the election and issue a challenge to the commissioners at a future meeting. He added that he attended the Station 17 Halloween Open House dressed in a Nutcracker's Drosselmeyer costume, he had a performance in Auburn at 3PM that afternoon.

Captain Krystofiak congratulated Commissioners Parsons and Sartnurak on their electoral victories, stating it is good to have them both back.

Commissioner Schneider echoed Captain Krystofiak's congratulations to the recently elected Fire District 40 commissioners and added congratulations to District Secretary Taylor as newly elected King County Fire District 43 Commissioner for Maple Valley.
